## 2012-2013 OPEN CHAMPIONSHIP TOURNAMENT RULES

1. All entries into this tournament must be made in accordance with United States Bowling Congress rules.
2. All adult members of the Greater Danbury USBC Association are eligible to enter.
3. This is an OPEN Handicap Tournament using 100% of 240.
4. Averages: Entrants shall use their highest USBC average from the previous regular season. Summer averages (minimum of 15 games) are acceptable if a bowler has no previous regular season average. Bowlers not listed in a yearbook or without a prior summer average shall use their highest current average based on a minimum 21 games or more bowled prior to the starting date of this tournament. **USBC rule 319a.2 is in effect. When the previous season's average is used, and at the time of bowling an entrant has a current average for 21 or more games that is 10 pins or more higher than the prior season's average, the current average must be used. In accordance with USBC rule 319b all others shall bowl scratch.**  
> **A current league sheet is required at check-in.** <
5. A bowler desiring to bowl either the singles or doubles event must enter both. When a bowler competes more than once, their first appearance in each event shall count towards all events score. In no case shall the same individual be permitted to place more than once in the prize list for position standing. Participation in singles and doubles shall be unlimited but the bowler may cash only once with the same partner. Not more than one (1) PBA member may bowl on the same doubles team.
6. Any four (4) persons may enter as a team as many times as they wish under the following conditions:
  - a.) Not more than two (2) players on the same team can place more than once in the prize list for position standings.
  - b.) A bowler participating more than once in the team event must count their first score for all events.
  - c.) No more than one (1) PBA member may bowl on the same team.
7. Lane assignments will be made by the Tournament Director. In the singles and doubles, singles will be bowled first and then all teams will move for the doubles.
8. Doubles and singles event: two doubles teams will be scheduled on each pair of lanes based on lane availability.
9. **All participants** shall report to the Tournament Check-in Desk **30** minutes before a scheduled event.
10. The Greater Danbury USBC Association can require a member to use their re-rated average if they have been re-rated by the Averages Committee of the Association in full accordance with the procedure outlined under *USBC rule 319c,e*. If a bowler reports an average higher than their true average, they will be required to use the lesser handicap. If a bowler reports an average less than their true ability, they are subject to disqualification and possible suspension from USBC.  
> **Report your own average. Do not depend upon someone else to do it for you.** <
11. No entry money shall be refunded for any reason after prize lists are completed.
12. Bowlers who have qualified for a prize of \$600.00 or more in any event in a tournament within the previous 12 months must report their actual scores, position and amount won. Failure to do so shall forfeit tournament entry fees and prize winnings. In addition, if such a bowler has exceeded their entering average by reason of *USBC rule 319a* or *rule 319b*, they must submit for re-rating in accordance with the rule. Failure to report prize winnings or submit for re-rating under *USBC rule 319d* shall be cause for disqualification.
13. All Events: the net All Events winner shall receive the USBC chevron. Entry fee is not required.
14. A game in which scores are lost (not retrievable) will be re-bowled.
15. Any rules that are not covered by the above shall be governed by USBC rules.
16. ATTIRE: Members are required to wear suitable attire while participating in the tournament.
