2013 "Virtual" YOUTH Bowl with the Pros Tournament Rules

- 1. This is a "virtual" format tournament open to all YOUTH USBC sanctioned bowlers. This is a singles tournament. All entrants must be members in good standing of USBC for 2012-2013 season.
- 2. Entry fee of \$10 for this tournament can be paid any time before or during the February 2nd through March 2nd, 2013 qualifying period. However, the entry fee must be received before qualifying will commence. Qualifying will run from the time the entry is paid until March 2, 2013
- 3. Format: Each prepaid bowler will use their <u>best 3-game series bowled</u> during regular league play once entry fee is paid before or during the February 2nd through March 2nd 2013 qualifying period (If your league format is more than three games, then <u>first three games</u> will be used for qualifying.)
- 4. It is the bowler's responsibility to request a copy of their score sheet(s) from the bowling center which needs to be submitted for qualifying. Score sheets must be verified & signed by the league secretary to be eligible. Failure to have score sheets verified will result in disqualification.
- 5. <u>Verified score sheets</u> need to be submitted no later than <u>by midnight on March 2, 2013</u> to be eligible. (Score sheets received after this deadline will result in disqualification.
- 6. Score sheets can be submitted as follows:
 - a. E-mail qualifying scores to Joel Reichin at joeldba@comcast.net
 - b. Leave <u>verified score sheets</u> in "Virtual YOUTH Bowl with the Pros Tournament" envelopes which will be made available at both Brookfield Lanes & Lore's Lanes (e-mail the tournament director to advise that scores were left there.)
- 7. Handicaps shall be based on 100% of 240 Average per person
- 8. The top two bowlers will qualify to Bowl with the Pros at the 29th Annual Strike-a-Thon. Sunday, April 7, 2013 at Brookfield Lanes. No entry money shall be refunded for any reason after competition starts.
- 9. Make-up games, Pre-Bowl or Post-Bowl scores are not eligible for this tournament.
- 10. All entrants shall use their highest USBC 2011/2012 book average. Entrants with no previous winter average shall use their highest 2012/2013 USBC league sanctioned average <u>based on 21 or more games at the time of bowling qualifying scores</u>. <u>Please attach a copy of your current league sheet with your entry payment form for average verification</u>. If the entrant has no average based on any of the above conditions, then he/she shall <u>bowl scratch</u> (see rule 319b).
- 11. USBC rules 319a-2, 319c, and 319d shall be waived.
- 12. It shall be each entrant's responsibility to verify the accuracy of his/her average (see rule 319a-3). Failure to use the proper average shall result in disqualification of all scores bowled by the entrant.
- 13. All participants agree to abide by the GDUSBC Tournament Dress Code for Bowling with the Pros only
- 14. The tournament committee has the authority to render decisions on anything not specifically covered in these rules
